**Registration Period** All dogs/cats over the age of three (3) months must be registered or re-registered by **10 April each year.**

The registration tag must be worn on the collar at all times.

**Documents** For entitlements to reduced registration fees the owner of the animal must produce proof of sterilisation, microchip implant, or pension concession card.  
**(Does not include Health Care Card Holders.)**

**Microchip Identification** From 1 May 2007 all cats or dogs being registered with a Council for the first time must be microchipped prior to registration. This includes animals transferring from another municipality. Documented proof of microchipping details must be provided at the time of registration.

**State Government Levy** Your registration fee includes the State Government Levy of \$3.50 per dog and \$2.00 per cat. This levy is used to fund responsible pet ownership education programs.

## Privacy

The personal information requested on this registration form is being collected by Council to maintain the Animal Registration Register as required by law. The information will be used by Council for that primary purpose or directly related purposes and will not generally be released to a third party unless required to do so by law. The applicant understands that the personal information provided is for the purpose described above, and that they may apply to Council for access and/or amendment of the information.

## Excess Animal Permits

A permit must be obtained to keep more than two dogs and/or two cats per residential household. Application forms are available from Customer Service.

## Restricted Breeds

The following restricted breeds must be declared:

- Pitbull Terrier
- American Pitbull Terrier
- Fila Brasileiro
- Dogo Argentino
- Japanese Tosa
- Perro De Presa Canario

American Staffordshire Terriers are not considered Restricted Breed Dogs providing one of the following certificates are provided:  
A pedigree certificate from the Australian National Kennel Council;  
A pedigree certificate from a member body of the Australian National Kennel Council;  
A pedigree Certificate from a national breed council registered with the Australian National Kennel Council; or  
A certificate signed by a veterinary practitioner stating that the dog is of a particular breed.



## Penalties Apply to:

Owners of unregistered animals.  
Owners of animals found wandering at large.  
Owners of animals found not wearing a current registration tag.

## Permits & Local Laws

Council's Local Law No. 8 requires that:  
The number of animals per household is restricted to two dogs & two cats, otherwise you may need to apply for a permit.  
Dog owners must remove excrement left by their dog on nature strips and Council land.
