Information privacy principles in brief

IPP 1 - Collection	Only necessary personal information will be collected to perform one or more of the Council's functions or activities.			
IPP 2 – Use and Disclosure	A Council may only use or disclose personal information for a "secondary purpose" in specified circumstances, including: the secondary purpose is related to the primary purpose of collection and use or disclosure is within the reasonable expectations of the individual; or the individual has consented.			
IPP 3 – Data Quality	Council must take reasonable steps to ensure personal information is accurate, complete, and up to date.			
IPP 4 – Data Security	Council must take reasonable steps to protect personal information from misuse and loss and from unauthorised access, modification, or disclosure.			
IPP 5 - Openness	Council has its Privacy Policy readily available and accessible on its website www.maroondah.vic.gov.au			
IPP 6 – Access and Correction	Council must take reasonable steps to ensure personal information is accurate, complete, and up to date. Individual have a right to seek access to their personal information and seek corrections.			
IPP 7 – Unique Identifiers	A "unique identifier" is a number assigned by an organisation to an individual to identify that individual but does not consist only of the individual's name. Council will not use or disclose any unique identifiers assigned by other organisations.			
IPP 8 - Anonymity	Wherever lawful and practicable, individuals must have the option of not identifying themselves in transactions with a council. However, this may render some services impracticable.			
IPP 9 – Transborder Data Flows	Council may only transfer personal information outside Victoria in circumstances where the information will have appropriate privacy protection.			
IPP 10 – Sensitive Information	Sensitive information includes information about an individual's racial or ethnic origin, political opinions, membership of a political, professional or trade association, philosophical or religious beliefs or affiliations, membership of a trade union, sexual preferences or practices or criminal record. Sensitive information must not be collected unless the individual has consented.
