CONDITIONS OF ISSUE AND USE FOR TRADER PARKING PERMITS

The following conditions of issue and use apply to the Trader Parking Permit Scheme:

- a) Trader Parking Permits must be displayed in the front windshield of the vehicle in a conspicuous manner or as otherwise prescribed by Council on the permit or information accompanying the permit. All permit details must be clearly visible from the outside of the vehicle.
- b) A Trader Parking Permit must only be used by employees of the business issued with the permit.
- c) A Trader Parking Permit is valid only in the streets or areas specified on the permit and identified by parking control signs.
- d) Trader Parking Permits are not valid for trailers, boats or caravans.
- e) Trader Parking Permits are not valid for vehicles over 4.5 tonnes gross vehicle mass (GVM) or exceeding 7.5 metres in length.
- f) A Trader Parking Permit cannot be shared between businesses, transferred or sold.
- g) A permit is not valid for parking an unregistered vehicle or parking a vehicle in a manner contrary to the *Road Safety Road Rules 2017* or the Maroondah City Council Local Law.
- h) A permit must not be duplicated in any way and duplicates of any kind are not valid.
- i) Once a permit has been issued, the permit holder is ineligible for a full or partial refund.
- i) Use of a permit in contravention of these rules may be considered fraudulent and result in:
 - i. The immediate cancellation of the permit and any other parking permits issued to the permit holder's business; or
 - ii. A ban from obtaining further Trader Parking Permits for a period of up to five years; or
 - iii. A warning or prosecution for an offence under the Maroondah City Council Local Law; or
 - iv. The matter being referred to Victoria Police; or
 - v. Any combination of the above.

Any action taken by Council in response to a breach of these rules shall be in accordance with the Maroondah Organisational Compliance Policy.

Trader Parking Permits in some areas may also be subject to permit specific rules, which are displayed on the permit and published on Council's website.


